### Athena Population Health Solution

ColigoCare is using the Athena Population Health Solution for collecting and analyzing financial and clinical data. At this time, we have compiled our CMS data and are working closely with Athena to import our commercial payer information.

In addition, the build-out of interfaces for non-Athena practices are in progress and, as such, the data is starting to be collected.

### Uniphy App

Great news! Secure, open communication will soon be available to ColigoCare providers via Uniphy, our branded communication tool. Uniphy will enable

you to send secure text messages and other correspondence directly to your ColigoCare colleagues. It will also provide you with streamlined access to important ColigoCare information such as phone numbers, events and newsletters.

We are working with the app company to design our customized ColigoCare app, and we anticipate that it will be available in early fall. Once the app is finalized, it will be accessible through your smart phone or tablet device.

## Population Health Bulletin



**Toni Modak, RN**, has been the Director of Population Health for just over a year and was integral to the development and implementation of the department. Toni came to ColigoCare with 28 years of clinical and leadership experience and has spent the last 10 years collaborating with post-acute providers and improving transitions of care

and quality outcomes across the health care continuum.

Through the dedication of Toni and the Population Health team, members of ColigoCare are now able to use the Population Health department as a resource for managing patients with multiple comorbidities and/or those who are considered to be medically high risk.

Some of the resources that are currently available to providers are:

- Care transitions coordinators, who identify ColigoCare patients admitted to the hospital, communicate with providers, monitor patients as they are transitioned into post-acute care settings and coordinate community resources to help avoid re-hospitalization and improve patient outcomes.
- Population health specialists (gaps in care) are a team that monitors quality reports and communicates any gaps in care to the individual practices.
- Post-acute care navigators follow patients admitted to skilled nursing facilities to emphasize quality care, provide education and help to determine appropriate discharge planning.

## Quality Improvement Corner



**Joshua Gregoire, MS, MPH, RN**, joined ColigoCare in June as the Quality Manager. Josh has a background in community health and

care transitions and most recently worked at a multi-site Federally Qualified Health Center (FQHC) in Manhattan where he was in charge of infection control, nursing quality and clinical workflow.
